**Gift Aid Declaration** - Gift Aid is a simple scheme that enables charities to reclaim the basic rate of tax on donations received from UK taxpayers. If you are a UK taxpayer and wish your subscription or donation to be treated as Gift Aid simply sign the declaration overleaf.
